

## Remix.gg Sweepstakes Official Rules & Terms

**Last Updated: May 30, 2026**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

These Official Rules (“Rules”) govern participation in all sweepstakes (“Sweepstakes”) offered through the Remix.gg platform, website, native mobile applications (iOS and Android), and related services (collectively, the “Platform”) operated by Farworld Labs Inc. (“Sponsor,” “Company,” “we,” “us,” or “our”).

**Important Notice Regarding Apple:** Apple Inc. is not a sponsor of any Sweepstakes, nor is it involved in any way with the administration, operation, or fulfillment of any Sweepstakes. Apple is not responsible for any aspect of the Sweepstakes, including prize fulfillment, and participants agree to release Apple from any and all liability related to the Sweepstakes.

By participating in any Sweepstakes, you agree to be bound by these Rules, our general Terms of Service, and Privacy Policy, which are incorporated herein by reference. In the event of any conflict, these Rules control with respect to the Sweepstakes.

These Official Rules are available within the Remix.gg iOS application at all times via the Sweepstakes section / dedicated rules screen.

### 1. Eligibility

Sweepstakes are open to users of the Remix.gg Platform who meet the age and account requirements in our Terms of Service. Specifically:

- You must be at least 13 years old.
- If you are under 18 years of age (a “Minor”), you may only participate with the approval and oversight of your parent or legal guardian. By participating, the parent or guardian represents that they accept these Rules on behalf of the Minor and remain fully responsible for the Minor’s participation.

The Sweepstakes is open to participants worldwide, subject to compliance with all applicable local laws and regulations in your jurisdiction of residence. It is your (or your parent/guardian’s) sole responsibility to determine whether participation is legal where you reside. The Sweepstakes is void where prohibited or restricted by law.

Employees, officers, directors, agents, and representatives of Sponsor, its affiliates, subsidiaries, advertising and promotion agencies, and any other entities involved in the administration of the Sweepstakes, as well as their immediate family members (spouse, parents, siblings, children) and those living in the same household, are not eligible.

Participants must comply with all Sweepstakes, gambling, and promotional laws in their jurisdiction. By entering, you represent and warrant that you are eligible and that your participation does not violate any applicable laws.

## **2. Sweepstakes Period**

Each Sweepstakes will have its own entry period as specified in the promotional materials, in-app notifications, or on the Platform (the “Promotion Period”). Entries submitted outside the Promotion Period will not be eligible.

## **3. How to Enter / No Purchase Necessary**

Tickets or entries for Sweepstakes are earned primarily by playing eligible games on the Remix.gg Platform. Additional entry methods may be provided from time to time.

**Alternative Method of Entry (AMOE):** To enter without playing games or providing any other consideration, send a handwritten 3” x 5” postcard with your full name, date of birth, mailing address, email address, phone number, and the name of the specific Sweepstakes to:

Each postcard must be mailed separately and received by the end of the Promotion Period. Limit one (1) AMOE entry per person per Sweepstakes. AMOE entries will receive the same number of tickets/entries and equal chance of winning as standard entries.

All entries must be received during the Promotion Period. Sponsor is not responsible for lost, late, incomplete, invalid, or misdirected entries.

## **4. Entry Limit & Ticket Usage**

Limits on the number of tickets/entries per person, account, or household will be specified per Sweepstakes. Entries/tickets are non-transferable. Multiple accounts per person are prohibited and may result in disqualification.

## **5. Winner Selection & Notification**

Winners will be selected by random drawing from all eligible entries received. Odds of winning depend on the total number of eligible entries received. Potential winners will be notified via email, in-app notification, or other contact method provided during registration, typically within

14 days after the Promotion Period ends. Sponsor is not responsible for undeliverable notifications.

To claim a prize, a potential winner (or their parent/guardian if a Minor) must respond within the time specified in the notification and complete and return all required documents, including (but not limited to) an Affidavit of Eligibility, Liability/Publicity Release (where permitted by law), IRS Form W-9 or equivalent (or local tax equivalent), and any other verification materials. Failure to do so may result in disqualification and selection of an alternate winner.

## **6. Prizes**

Prizes vary by Sweepstakes and may include cash, gaming consoles, computers, gift cards, merchandise, or other items as described in the promotional materials. Approximate Retail Value (ARV) will be disclosed. Total ARV of all prizes in a Sweepstakes will be stated where required.

**Cash Prizes:** Cash prizes will be issued via electronic transfer or check. All cash prizes are subject to tax withholding and reporting as required by law.

**Non-Cash Prizes:** Sponsor reserves the right to substitute a prize of equal or greater value if the advertised prize becomes unavailable. Sponsor may, in its sole discretion, award the cash equivalent of a non-cash prize (minus any applicable taxes or fees) if shipping, delivery, or fulfillment becomes impractical, impossible, or unduly burdensome due to logistical issues, legal restrictions, winner location, or other reasons. Winners (or their parent/guardian) are responsible for all costs associated with prize acceptance not expressly covered (e.g., travel, insurance, taxes, customs duties, or import fees for international winners).

Prizes are non-transferable and non-assignable. No substitution except by Sponsor. All prizes are awarded "AS IS" without warranty.

## **7. Taxes & Reporting**

Winners are solely responsible for all federal, state, local, and international taxes, duties, and any other costs or expenses associated with prize acceptance and use. Sponsor will issue IRS Form 1099-MISC or equivalent (or local equivalent) for prizes valued at \$600 or more (or as otherwise required by law). Failure to provide required tax documentation may result in forfeiture of the prize. International winners may be subject to withholding taxes or other deductions as required by law.

## **8. Publicity**

By accepting a prize, you (and your parent/guardian if applicable) grant Sponsor and its designees the irrevocable right to use your name, likeness, voice, biographical information, and statements for advertising, promotional, and publicity purposes worldwide in any media, without additional compensation, notice, or approval, except where prohibited by law.

## **9. Limitation of Liability & Release**

By participating, you (and your parent/guardian if a Minor) agree to release, discharge, and hold harmless Sponsor, its affiliates, partners, and their respective officers, directors, employees, agents, and representatives from any and all claims, damages, losses, liabilities, costs, or expenses arising out of or related to your participation, prize acceptance, use, or misuse, or any Sweepstakes-related activity. This includes (but is not limited to) personal injury, death, property damage, or claims based on publicity rights, defamation, or invasion of privacy.

Sponsor is not responsible for: (a) technical failures, lost/delayed entries, or Platform malfunctions; (b) unauthorized human intervention; (c) printing/production errors; or (d) any force majeure events.

## **10. General Conditions**

- Sponsor reserves the right to cancel, suspend, or modify any Sweepstakes for any reason, including fraud, technical issues, or regulatory requirements.
- Sponsor may disqualify any entrant who tampers with the entry process, violates these Rules, or acts in an unsportsmanlike or disruptive manner.
- All decisions of Sponsor are final and binding.
- These Rules cannot be modified or waived except in a written document signed by an authorized representative of Sponsor.

## **11. Governing Law & Dispute Resolution**

These Rules are governed by the laws of the State of Colorado, without regard to conflict of laws principles. Any disputes shall be resolved pursuant to the arbitration, class action waiver, and other dispute resolution provisions in our general Terms of Service.

## **12. Privacy**

Personal information collected in connection with a Sweepstakes is subject to our Privacy Policy. By entering, you consent to the collection, use, and sharing of your information as described therein and for Sweepstakes administration purposes.
